## **Parental Consent**

## Temporary Remote Instrumental Lessons (via skype / TEAMS / Zoom etc.) from Wigan Council Music Service

- Due to the current national lockdown, face to face instrumental lessons are paused. However, Wigan Music Service is undertaking to establish remote instrumental lessons for those pupils who are existing learners having instrumental lessons in the autumn term 2020. WMS instrumental tutors are freelance practitioners and not all are in a position to offer this remote service. As freelancers, it is at their own discretion as to whether they wish to undertake such work.
- 2) I understand that upon receipt of this form, the Wigan Music Service admin team will coordinate and administrate this remote tuition, but the details of when the tuition will take place will be handed over to the instrumental teacher who will contact me (parent) directly to negotiate a mutually convenient time.
- 3) I understand that signing this form will give explicit signed consent for Wigan Music Service to share my email address with a single named instrumental teacher. Wherever possible, this will be my child's regular instrumental teacher. This will enable the teacher to liaise directly with regards to the lesson arrangements and then to facilitate the video lessons (Zoom / Teams) themselves.
- 4) I understand that instrumental teachers are not employees of Wigan Council. They are genuinely selfemployed. I understand that it will be entirely at the discretion of the instrumental teacher as to whether or not they choose to undertake remote teaching engagements.
- 5) All Wigan Music Service registered freelance tutors are DBS checked (Wigan Council), have received Safeguarding training and are experienced 'in-school' practitioners. Wigan Music Service will only ever invite appropriately qualified and experienced teachers to undertake remote lessons.
- 6) In signing this consent form I am agreeing to pay Wigan Music Service (Wigan Council) for the teaching services provided. I understand that I will be invoiced on a termly basis (in arrears) for the lessons received. In the first instance, I must notify Wigan Music Service directly BY EMAIL to <u>musicserviceenquiries@wigan.gov.uk</u> if I need to cancel the lesson. Teachers will make pay claims to Wigan Music Service based on the actual lessons delivered. Parental payment instructions will be provided at the point of invoicing.
- 7) ONLY A PARENTAL EMAIL ADDRESS SHOULD EVER BE DISCLOSED TO WIGAN MUSIC SERVICE OR THE INSTRUMENTAL TEACHER. NEVER SHOULD A CHILD'S EMAIL ADDRESS (OR ANY OTHER MEANS OF ELECTRONIC COMMUNICATION) BE DISCLOSED.
- 8) I It is a condition of this arrangement that a responsible adult (normally parent) is present to oversee / supervise the remote lesson, remaining within the room throughout. Parents must ensure that a suitable room in the home is available for the lesson. This should be a shared space in the home (NOT a child's bedroom). There should be no distraction from siblings. Pupils must wear appropriate clothing.
- 9) I acknowledge that freelance tutors will be establishing contact via their private email account. Parents must not use this email contact for any other purpose than the organisation of instrumental lessons.
- 10) I acknowledge that I will be entering into an agreement with Wigan Council Music Service for the provision of remote instrumental lessons and that I will be invoiced in arrears at their standard rates.
